Shake well before using. ferti-lome® TOMATO & PEPPER SET solution is ready to use as is. To promote blossom set and fruit development, spray the flowers and adjacent foliage with this product until the leaves are completely wet. Repeat as blossoms appear or at one- to two-week intervals.

FIRST AID
